- (b) whether any compensation has been given in this regard.
- (c) if so, what are the details thereof:
- (d) whether the mills have since started functioning;
- (e) whether all the employees have been re-employed;
- (f) if not what is the number of employees who have not been taken back; and
- (g) whether the daily rate of production of these mills have increased in comparison to the earlier rate of daily production; if so, to what extent?

(b) and (c) Government has taken over only the management of these undertakings, and therefore, the question of payment of compensation does not arise.

(d) Yes, Sir.

(e) and (f) All the employees these undertakings, except those employed in the Kanpur Unit, had been lying closed prior to take re-employed. over have been notice has been put up asking the workers of Kanpur Unit to report for duty, and about 1.500 workers out of

- a total of about 6200 workers have reported.
- (g) These undertakings were taken over on 14th April, 1978 only. It is, therefore, too early to assess and compare their output for pre and post take over periods.
