Non-appointment of a Medical Superintendent for the Jipmer Hospital[†] Pondichery

*354. SHRI V. P. MUNUSAMY:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to-state:

(a) whether it is fact that the Jipmer Hospital, Pondichery is the only hospital in India under the direct control of the Central Government and that it is functioning without a Medical Superintendent from the day it was set up;

(b) what is the name of the authority who is looking after the day to day administration of the Hospital; and

(c) whether Government have initiated any action to create or to fill up the post of Medical Superintendent in the Hospital in the near future?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI JAGDAMBI PRASAD YADAV).- (a) and (b). No, Sir. There are other hospitals also in India which are under the direct control of the Government. It is, however, a fact that the Jawahar-lal Institute of Post Graduate Medical Education and Research has been functioning without a Medical Superintendent from the day it was set up. The day-to-day administration of the hospital is being looked after by the-Senior-most Professor who is designated as Additional Medical Superintendent. There is also a full-time Deputy Medical Superintendent who is assisting the Principal through the Additional Medical Superintendent.

(c) A post of Medical Superintendent in the scale of Rs. 2250—125/2—2500 has been sanctioned on 22nd April, 1978. Necessary action to fill the newly-created post has been initiated.
