

Loss of Revenue to States on Introduction of Prohibition

Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

(a) whether some State Governments have furnished to the Central Government their estimates of loss of revenue on introduction of prohibition in their States and have urged the Central Government to compensate them on that account;

(b) if so, what are the details in this regard; and

(c) what is the reaction of the Central Government in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION, SOCIAL WELFARE AND CULTURE (SHRI DHANNA SINGH GULSHAN):

(a) Yes, Sir. The Governments of Bihar, Uttar Pradesh and Tamil Nadu have furnished estimates.

(b) The Government of Bihar has estimated the loss of revenue as Rs. 7.3 crores in 1978-79, Rs. 15.14 crores in 1979-80 and Rs. 23.61 crores in 1980-81. The Government of Uttar Pradesh has estimated a loss of Rs. 20.00 crores in 1978-79.

The Government of Tamil Nadu has estimated a loss of Rs. 140 crores in 1978-79.

(c) The Centre expects to compensate the States to the extent of 50 per cent of the established loss of excise revenue in each year commencing from 1978-79 treating the annual excise revenue of 1977-78 as the base. This will not include possible increases which may have occurred in excise revenue, cost of enforcement etc.
