*25. SHRI PRASENJIT BARMAN: SHRIMATI PRATIMA BOSE: SHRI JAHARLAL BANERJEE:

Will the Minister of RAILWAYS be pleased to refer to the answer to Unstarred Question 814 given in the Rajya Sabha on the 20th March, 1978 and state;

- (a) what is the composition of the Recruitment Committee on the Northeast Frontier Railway;
- (b) whether there is any proposal under Government's consideration to include the nominees of the West Bengal and Bihar Governments in the said Recruitment Committee: and
 - (c) if not, what are the reasons therefor?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): (a) to (c) A statement is laid on the Table of the House.

(a) The Recruitment Committee consists of three Railway officers nominated by the Generai Manager. The Principal of a College nominated by the Government Of Assam, is coopted as Member whenever the Committee sits.

(b) No.

(c) Besides West Bengal and Bihar the Northeast Frontier Railway covers portions of the States of Nagaland and Tripura also. n will not be practicable to include nominees of all State Governments in the area in a Commission or single Recruitment The views of the Committee. state Governments of West Bengal and Bihar are given due consideration while filling posts by the Railway Service Commissions located at Cal cutta and Muzaffarpur, which also cover West Bengal and Bihar.

Level-crossing barriers in Kanpur cits

Will the Minister of RAILWAYS be pleased to state:

- (a) whether Government aware of the serious dislocation in the flow of traffic as a result of several level-crossing barriers in Kanpur city;
- (b) whether it is also a fact that traffic bottlenecks at these level-crossings is a regular feature; and
- (c) what steps Government propose to take for solving this serious traffic problem?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN); (a) and (b) Due to heavy road and rail traffic, con. siderable detention to traffic occurs at some of the level crossings.

(c) It is the Railways' policy to replace such level crossings gradually by road over or under.bridges on a cost-sharing basis mih the State Government/Road Authority. One such road over-bridge has lfceritly been completed and another one is presently under construction in Kanpur area.
