The remaining 100 schools have been allowed to offer only the secondary course, i.e., upto X standard. This rMnge-over has not resulted in reduction of posts in higher scales to which the school teachers are normally entitled for promotion.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH): (a) A quantity of 13.4 million tonnes of foodgrains has bee'n held in storage by the Food Corporation of India as *On* 1st April, 1978.

(b) Out of the above stocks, only a quantity of 0.52 lakh tonnes is damaged and unfit for human consumption.

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state;

- (a) whether Government have received any proposals from the Governments of Punjab, Haryana and Uttar Pradesh for revision of the procurement price of wheat;
- (b) if so, what are their demands and what decision the Central Government have taken thereon; and
- (c) whether any assessment has been made about the cost of production of different varieties of wheat in different States and if so, what are the details thereof?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) and (b) In the course of discussions oru pricing policy for wheat for 1978-79 season, the Chief Ministers of Punjab, Haryana and Uttar Pradesh had suggested that the procurement price of wheat may be raised to Rsj 125 per quintal while the Agricultural Prices Commission had recommended that it may be maintained at Rs: 110 per quintal. After careful consideration, Government have decided to fix the procurement price for wheat of fair average quality at Rs. 112.50 per quintal for all varieties.

(c) Under the Comprehensive Scheme for studying the cost of cultivation of Principal crops being implemented by the Ministry 0f Agriculture and Irrigation, mostly through Agricultural Universities, the estimates of cost of production per quintal of wheat in Punjab, Haryana
