Radiation Hazard at the Tarapur Atomic Power Station

*99. SHRI U. K. LAKSHMANA GOWDA: SHRI G. LAKSHMANAN; SHRI C. D. NATARAJAN; SHRI R. NARASIMHA REDDY: SHRI KHURSHED ALAM KHAN;

Will the PRIME MINISTER be pleased to state;

(a) whether it is a fact that lack of adequate dumping facilities for irradiated rods and storage capacity for spent fuel at the Tarapur Atomic Power Station is resulting in radiation hazard there; and

(b) if so, what preventive steps Government have taken or propose to take in this regard?

THE PRIME MINISTER (SHRI MORARJI R. DESAI): (a) and (b) There is no radiation hazard at the Tarapur Atomic Power Station as the spent fuel bundles are carefully stored in special racks in a spent fuel storage pool. Government have initiated action to increase the storage capacity for future requirements.

Industrial Crisis due to shortage of Coal

Will the Minister of ENERGY be pleased to state:

(a) whether it is a fact that shortage of coal has created an industrial crisis in the Southern and Western regions of the country;

(b) if so, to what extent industrial production in those regions has been affected due to this shortage; and

(c) what remedial measures Government are taking to regulate the supply of coal to industries in those region?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) No, Sir.

(b) Does not arise.

(c) Adequate pithead stocks are available at present and a close coordination is being maintained with the Railways to move coal to industries in those regions.

Television Centre at Cooch-Behar in West Bengal
