It is our duty and also, I think, you will agree that it is proper that you kindly find some time for discussing this according to the convenience of the Prime Minister. Many 'notices have been given.

Metallurgi-i cal and Engineering Consultants (India) Limited is not directly involved therein but is associated in a few projects as a consultancy organisation. The programmes are coordinated with Central Fuel Research Institute and Central Mine Planning and Design Institute t0 avoid a'ny duplication of efforts except where, because of the importance of the projects, more than one approach is considered useful.

No briquetting tests On Indian coals have been carried out by M|s. Sumitomo of Japan on behalf of Steel Authority of I'ndia Limited. However, laboratory screening tests on Indian coals have been recently conducted by M|s. Nippon Steel Corporation of Japan as a preliminary step to decide whether their briquette ble'nd coking process can be adopted by the steel plants in India.
