THE MINISTER OF STATE IN THE DEPARTMENT OF SCIENCE AND TECHNOLOGY IN THE MINISTRY OF SCIENCE AND TECHNOLOGY (SHRI BACHI SINGH RAWAT): (a) The Technology Development Board, constituted in terms of Technology Development Board Act, 1995, comprises eleven members, six of whom are *ex-officio* members, drawn from scientific and socioeconomic Departments/Ministries of the Central Government, as under: -

(2)	Secretary to the Govt, of India, Deptt, of Scientific & Industrial Research.	Member

(5)	Secretary to the Govt, of India, Deptt, of Industrial Policy & Promotion.	Member
(6)	Secretary to the Govt, of India, Deptt, of Rural Development.	Member

In addition, the Board has four non-official members appointed by the Central Government from amongst persons having experience in the technology development and application, banking and finance, industry, agriculture and rural development. Besides, the Secretary to the Technology Development Board is also an *ex-officio* member of the Board.

(b) The Technology Development Board has been set up to provide financial assistance to industrial concerns and other agencies attempting

development and commercial application of indigenous technology or adapting imported technology to wider domestic applications and for matters connected therewith or incidental thereto.

(d) The Technology Development Board extends financial assistance for the development and commercialisation of new products, processes and applications through indigenous technological efforts for sectors such as agriculture, chemicals, engineering, electronics and telecommunications, environment, medical and health, information technology, transporation, etc.
