**Situation arising out of closure of Banaras  
Hindu University**

SHRI DEYENDRA NATH DWIVEDI (Uttar Pradesh): Sir, I beg to call the attention of the Minister of Education, Social Welfare and Culture to the situation arising out of the closure of the Banaras Hindu University for an indefinite period and the eviction of students from the University Hostels.

THE MINISTER OF EDUCATION, SOCIAL, WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): Mr. Deputy Chairman, Sir, according to the information received from the Banaras Hindu University, a representation was made by some students of the Faculty of Science on February 17, 1978 demanding *inter-alia* a weightage of 10 per cent in marks obtained by the bonafide students of the Banaras Hindu University appearing in the Pre-Medical Test, to be held in 1978 for entry to M.B.B.S. Course of the University Institute of Medical Sciences. Subsequently, there was also a demand for reservation of seats for the students of the University in the M.B.B.S. Course. As the matter was receiving consideration of the Faculty of Medical Sciences and the Academic Council of the University, the students were informed of the position by the Rector of the University personally and they were assured that the matter will be considered expeditiously.
