- (8) Several meetings, Conferences and Workshop<sub>s</sub> wer<sub>e</sub> held during this period to enlighten on newer paths of work and formulation of Government policy o'n Leprosy Control.
- (9) Arrangements have been made with Swedish International Development Agency to supply substantial quantity of Refampicin and Lawiprene drugs for the second lfeie treatment of leprosy patients.

Anomaly in the rate of interest paid on G. P.

## Fund/C. P. Fund contributions of the Delhi school teachers

- 264. DR. Z. A. AHMAD: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:
- (a) whether it is a fact that there is an anomaly in the rate of interest paid on the General Provident Fund/ Contributory Provident, Fund accumulations of

the teachers of the Government Schools and those of the recognised and aided schools of the Delhi Administration;

- (b) if so, what is the rate of interest paid at present on these contributions, separately;
- (c) what action. Government pro pose to take to remove this anomaly?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION, SOCIAL WELFARE AND CULTURE (SHRIMATI RENUKA DEVI BAR-AKATAKI); (a) According to information received fr\*om the Delhi Admn. the rate of interest paid on the contribution made by Government servants in G.P Fund and the rate of interest on P 'ovident Fund of teachers employed in private aided schools are different. There is, however, no anomaly involved in this because the Provident fund contributions of staff working in aided schools are deposited in individual Banks and not in Government accounts.

(b) The rate of interest on accumulations in G.P, Fund for the year 1977-78 is 8 per cent for accumulations upto Rs. 25,000/- and Rs. 7.5 per cent for accumulations in excess of Rr∖

- 25,000. The rate of interest allowed by banks on the accumulations in Provident Fund of teachers of aided schools vary from bank to bank depending on the nature of the account. By and lagre the interest earned on these accounts compares favourably with the rate of interest allowed by Government on accumulations in G.P. Fund.
- (c) Any specific case of anomaly brought to Government's notice will be looked into.
