#### Suggestion for the transfer of 'Electricity' from the Concurrent List to the Union List in the Constitution

- \*345. SHRI S. K. VAISHAMPAYEN: Will the Minister of ENERGY be pleased to state:
- (a) whether it is a fact that the All India Power Engineers' Federation at their meeting held on the 5th February, 1978 at Delhi suggested the transfer of the subject of 'electricity' from the Concurrent List to the Union List in the Seventh Schedule to the Constitution and the formulation of a national power policy; and
- (b) if so, what is Government's reaction thereto?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) Yes, Sir. This has been reported in the newspapers.

(b) Existing legal framework enables Central participation and guidance in power development to the required extent. The Electricity (Supply) Act of 1948, which governs the organisational structure of electricity supply industry in the country, has recently been amended to enable development of a sound, adequate and uniform national power policy and formulation and coordination of short-term and perspective plans for power development effectively at the central level.

#### Running of computers centres by the IBM employees

- THE MINISTER OF HOME AFFAIRS (SHRI CHARAN SINGH): (a) The Government have seen a news item datelined Amritsar the 30th January, 1978, on the Minister's (Shri Chand Ram's) address in the Conference of the depressed classes, but he did not say that incidents of atrocities on Harijans and other backward classes were increasing.
- (b) Offences against members of the Scheduled Castes come within the definition of 'Public Order' which is a State subject according to Scheduled VII of the Constitution, and substantive action under the law has to be taken by the State Government concerned. However, the Centre keeps In close touch with the State Governments and offers suggestions to them from time to time to expedite measures aimed at removing the basic factors responsible for such incidents and for strengthening the administrative machinery to ensure prompt and effective action in all such cases and to provide protection to and instil a sense of security among the weaker sections.
