No specific ceiling has been fixed on the production of motor pump sets by large companies. However, since February, 1974 centrifugal pumps upto 10 cm k10 cm have been reserve for development in the small scale sector.

Admission of students belonging to the Scheduled Castes and Scheduled Tribes in schools & colleges in Delhi

*350. SHRIMATI RATHNABAI SREENIVASA RAO: Will the Minister of HOME AFFAIRS be pleased to state:

Artificial shortage of paper

*351. SHRI BHUPESH GUPTA: SHRI INDRADEEP SINHA: SHRI BISHAMBHAR NATH PANDE:

Will the Minister of INDUSTRY be pleased to state:

- (a) whether it is a fact that the book publishers have accused the manufacturers for creating artificial shortage of paper by manipulating supplies and prices and have upon Government to take necessary steps in the matter; and
- (b) if so, what action Government have taken to remedy the situation?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) Representations have been received from publishers to the effect paper manufacturers had increased prices of their products and that publishers are having difficulties obtaining papers at reasonable prices for the production of books.

(b) Although there is no statutory control on the price of papers, Government have been discouraging the industry from resorting to unilateral increases in price without adequate justification. Government's unhappiness at the price increases effected by some mills without consulting Government, has been conveyed to the Paper Industry. The reaction of the industry is awaited before Government takes suitable regulatory measures to control the price situation. Steps are also being taken to increase quantum of supply of concessional paper for the educational sector.
