units in Karnataka are not able to function at their optimum capacity. This is a fact and there is no contradiction in this. There is power shortage and it has been there over a period of time. Last year we lost half a million tonnes of cement production only because adequate power was not available in certain States.

MR. CHAIRMAN: Question Hour is over.

AN HON. MEMBER: In Karna-taka under which Government?

SHRI GEORGE FERN ANDES: It is because Shri Devraj Urs was in power and he continues to be there.

THE PRIME MINISTER (SHRI MOHARJI R. DESAI): For 1977-78 Annual Plan, the Government of West Bengal proposed an outlay of Rs. 312.12 crores. After discussions, an amonut of Rs. 310.92 crores was mutually agreed upon. Subsequently, an additional outlay of Rs. 5.00 crores was sanctioned for major and medium irrigation projects andRs. and Rs. 9.50 crore for minor irrigation projects raising the total plan outlay to Rs. 3.25 croTe_s was also approved as special Central assistance for hill areas of West Bengal.

Stoppage of import of mutton tallow used in the manufacture of soap

•336. SHRI S. KUMARAN: SHRI INDRADEEP SINHA:

Will the Minister of INDUSTRY be pleased to state:

- (a) whether Government have decided to stop the import of mutton tallow used in the manufacture ol soap;
- (b) if so, what are the reasons therefor; and
- (c) what will be its impact on tl?e prices of soap?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) and (b) Import of mutton tallow is allowed to soap manufacturers other than those in the organised sector. This policy is followed in order to encourage use of non-edible and non-conventional oils in soap making.

(c) The prices of soap are not rela-table only to import of mutton tallow but dependant on cost of different inputs which vary from time to time.
