THE MINISTIR OF PETROLEUM, CHEMICALS . \ND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) to (e) A s.atement is laid on the Table ol tha House.

St tement (a) to (d) The years allocations of indigenous paaffin wax to the States/Union Te 'ritories are made on the basis of tota expected availability of wax in a paticular year and the past upliftment performance of each State. In view if the limited indigenous availability of paraffin wax, for any additional equirements of wax, the State Gover iments were informed to advise the actual users under their jurisdiction to 1 egister their requirements with M/s Balmer Lawrie & Co. Ltd., Calcutta, *-ho are the canalising agency for mports.

The total allocations of indigenous paraffin wax in favour of various States /Union Territories during 1977 aggregated to < 2267 Metric Tonnes. A quota of 89f Metric Tonnes was allotted in favo ir of Madhya Pradesh during 1977 as against 598 Metric Tonnes during the previous year.

There was a shortfall of 145 Metric Tonnes in the positioning of paraffin wax in Madhya Pradesh *vis-a-vis* the State quota of 898 Metric Tonnes for 1977.

In view of the shortfall in despatches during 1977, wax allocations made in favour of Madhya Pradesh for the period January—June, 1978 have been enhanced by this quantity of 145 Metric Tonnes.

- (d) what action Government have taken or propose to take against the persons responsible for the damage to the film in storage?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): (a) to (d) A statement is laid on the Table of the Sabha. Statement

- (a) At the request of the Railwaymen's Fine Arts Society, Madras the film with all rights was purchased by the Railways for use in the normal publicity programme on safety.
- (b) The film was kept in a steel box and the storage arrangements were considered adequate.
- (c) Yes, Sir. The film was examin ed soon after the heavy downpour by the officials of the Southern Railway, the Films Division of the Government of India and the Gemini Studios, Madra*.

(cH An enquiry was instituted. It came ^o the conclusion that the damage to the film was caused by the heavy downpour. The rain water entered the room in which the box was kept and seeped into the box which damaged the film beyond repah'. On the recommendation of the Enquiry Officer, the official responsible for safe keeping of the film was advised to be more alert in future.

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) On 26-1-1978. while Down Goods train No. E/932 was passing through Jaswantnagar station, its engine and 16 wagons, derailed.

(b) No, Sir. According to the finding of the Inquiry Committee, the accident was due to the failure of mechanical equipment. Setting up of a petro.

The initial proposals were with regard to a petro-chemical complex based on a Naphtha Cracker; the latest proposals envisage production of aromatics and use of gases from a catalytic cracker.

(c) and (d) Investment approvals have been issued for setting up the following new petrochemical plants by IPCL at Baroda:
