THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOTTAM KAUSHIK): (a) The capacity offered on Boeing 737 bi-weekly service between Calcutta and Port Blair is about 100 seats each way. Its average occupancy is 55-60 passengers each way.

- (b) The runway load bearing strength is not adequate for operation of Boeing 737 aircraft with full load. The use of full length of the runway and all weather bi-directional operations are not possible due to the hills in the approach of each end of the runway.
- (c) The existing aerodrome can be developed only for visual uni-directional operations for Boeing-737. The comparative economics of developing the existing aerodrome and constructing a new aerodrome at an alternative site are being studied in view of the heavy investment involved in either case.

MINISTER ofFINANCE AND REVENUE AND BANKING (SHRI H. M. PATEL): (a) and (b) The price of gold touched an all time high of Rs. 710 per 10 grams on January 17th following demonetisation on January 16th due to speculative demand generated by apprehensions of demonetisation of notes of other denominations. However, this spurt was shortlived and price of gold declined soon thereafter to predemonetisation levels.

### Recovery of income-tax arrears from large industrial houses

- 7. SHRI KALYAN ROY: Will the Minister of FINANCE be pleased to refer to the answer to Unstarred Question 72 given in the Rajya Sabha on the 15th November, 1977 and state:
- (a) what are the names of the large industrial houses and companies whose gross arrears of income-tax exceeded Rs. 10 lakhs;
- (b) what is the number of the large industrial houses which have since paid Rs. 26.17 crores as arrears of income-tax and what are the details thereof:
- (c) what is the amount still outstanding; and
- (d) what steps Government have taken to recover the arrears and the results thereof?

MINISTER OF FINANCE THE AND REVENUE AND BANKING (SHRI H. M. PATEL); (a) and (b) Names of the 63 concerned tax-payers are given in the statement annexed. The gross tax outstanding against these 63 tax-payers as on 31-3-77 was Rs. 26.17 crores. During the period 1-4-77 to 30-9-77 there has been a collection/reduction of Rs. 4.52 crores out of the said amount of Rs. 26.17 crores, in 33 cases belonging to 17 large industrial houses.
