Tripartite Conference on Agricultural Labour

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND PARLIAMENTARY **AFFAIRS** (SHRI LARANG SAI) (a) Yes, Sh- A spe. cial Conference on Rural Unorganised Labour was held on the 25th January, 1978.

- 2. The Conference decided to set up a Central Standing Committee on Ru-

ral Unorganised Labour to advise the Government on matters relating to the conditions of work and life of rural workers and promotion of rural workers' organisations. It was decided that the definition of a rural worker should conform to the definition in ILO Convention 141. The consensus at the Conference was i*n favour of Central Legislation concerning agricultural workers and for the Ministry of Labour to process the matter further in the light of the views expressed at the Conference in regard to security of service; regulation of hours of work; fixation/revision of wages, social security measures and machinery to settle disputes.

In order to have a wide ranging consultation, some of the institutions/ organisations which are known to be functioning in this field were invited. Invitees were: (i) the State Governments; (ii) concerned Central Ministries, such as the Ministry of Agriculture, Department of Rural Development; (iii) workers' organisations, including the Central Workers' Organisations, operating in the rural sector; (iv) Voluntary Organisation/institutions/persons interested in the problems of rural labour; (v) Farmers' Associations suggested by the Ministry of Agriculture and (vi) Central Employers' Organisations (as observers).

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND PARLIAMENTARY AFFAIRS (DR. RAM KRIPAL SINHA). (a) The amount of provident fund contributions in arrears in respect of u'nexmpted establishments at the end of September, 1977 was Rs. 1961 56 lakhs.

Contributions due upto 30th September, 1976 which were in default under Employees' State Insurance Act was Rs. 1897 lakhs as on 30th September, 1977.

THE MINISTER OF PARLIAMENTARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA): (a) and (b) Government have seen Press reports on the observance of "anti-wage freeze day" by industrial workers in some parts of the country and has taken note of the views expressed by the trade unions which gave the call for the observance of the day.

Opening of a Passport Office in the Jammu and Kashmir State

THE MINISTER OF EXTERNAL AFFAIRS (SHRI ATAL BIHARI VAJPAYEE): (a) The Government of J&K has taken up with the Central Government, questions relating to improving the facilities available to people of that State for travel abroad.

(b) and (c) In $_0^{\rm rde}$ r to provide greater convenience to the public in some States, where they have to travel long distances for obtaining passport facilities, it has been decided to open Sub-Regional Passport Offices in these States. Accordingly, such an office will be opened i_n Jammu and Kashmir shortly.
