SHRI N. A. PALKHIVAEA AT THE  
UNIVERSITY OF RICHMOND**

DR. BHAI MAHAVIR: On a point of order .

MR. CHAIRMAN: The Question Hour is over. Something was said then. After that, I have gone to the second item. That is also over. Now, why are you raising point of order? I do not understand this. Even the second item is over.

SHRI ERA SEZHIYAN: I also wanted to raise a point of order.

DR. BHAI MAHAVIR: If you give me half a minute, then you will know whether there is point of order or not in what I am going to say . . .

(Interruptions)

SHRI ANANT PRASAD SHARMA: No, No.

DR. BHAI MAHAVIR: Can these gentlemen decide whether you should allow me to raise it or not? Have you delegated your authority to Shri Sharma and Kalp Nath Rai?

MR. CHAIRMAN: They have no such authority.

DR. BHAI MAHAVIR: Then, what I wish to state . . .

(Interruptions)

MR. CHAIRMAN: Listen to me. The Question Hour is over. Something was discussed then. Then I went to the second item. That is also over. Now the Leader of the Opposition wants to say something. Let me hear him.

DR. BHAI MAHAVIR: Is he on a point of order?

MR. CHAIRMAN: There is no question of point of order.

DR. BHAI MAHAVIR: But I am on a point of order. I wish to state ...

Should the floor of this House be defiled by making abusive references to high dignitaries .

(Interruptions).

SHRI ANANT PRASAD SHARMA: You have called the Leader of the Opposition.

DR. BHAI MAHAVIR: My friend here has used highly objectionable language . . .

DR. BHAI MAHAVIR: Sir, I do not know how you are allowing them to make such meaningless and nonsensical charges.

SHRI PRANAB MUKHERJEE: Sir, if he is not going to make a statement, then we will not allow any Minister to make any statement.

SHRI KAMLAPATI TRIPATHI: Sir, it must be on record. That copy should be put up before the House. That is my demand.

*(Interruptions)*

SHRI JAGJIT SINGH ANAND (Punjab): Sir, the Minister cannot escape like that.

*(Interruptions)*

DR. BHAI MAHAVIR: Sir, if somebody calls such a high dignitary as an American henchman, then I can also call them as the Russian henchmen. Will these things go on record? Will it be proper, Sir?

*(Interruptions)*

MR. CHAIRMAN: Can we now go to the next item, that is, the Calling Attention Motion?

SHRI ANANT PRASAD SHARMA: Sir, what is your decision on this matter?

SHRI PRANAB MUKHERJEE: Sir, what is your decision in the matter?

*(Interruptions)*

SHRI ANANT PRASAD SHARMA: Sir, a statement from him and a copy of the speech of Mr. Palkhiwala should be made available to us.

*(Interruptions)*

SHRI BHUPESH GUPTA: Sir, I fully support their demand.

SHRI PRANAB MUKHERJEE: Sir, let him ascertain from Mr. Palkhiwala and make available to us what he has said.

SHRI ERA SEZHIYAN: Sir, I have a point of order to make.

*(Interruptions)*

SHRI JAGJIT SINGH ANAND: Sir, the only thing is this: If this is to be decided . . . *(Interruptions)* . . . let him call for a copy of that speech. He can get a copy of that speech. It must be a prepared one and it has been reported. Let him get a copy of that and then we shall go through it and we shall go by that and we shall not go by what is said here and we will find out if there is something to hide in it . . . *(Interruptions)* Let him get a copy of that speech.

MR. CHAIRMAN: Shall we go to the next item of business?

*(Interruptions)*

AN HON. MEMBER: It has to be explained.

*(Interruptions)*

MR. CHAIRMAN: What is there to explain?

SHRI ATAL BIHARI VAJPAYEE: Sir, the Ambassador spoke extempore.

SHRI U. R. KRISHNAN (Tamil Nadu):  
How do you know?

SOME HON. MEMBERS: Very good.

*(Interruptions)*

MR. CHAIRMAN: Because he is the  
External Affairs Minister.

SHRI ATAL BIHARI VAJPAYEE: I am  
expected to know. No verbatim record of the  
speech was kept. When we received the same  
pamphlet which is in the possession of my  
honourable friend, Shri Kalp Nath Rai, we  
made inquiries. This pamphlet was circulated  
by a private individual...

AN HON. MEMBER: Like Mr. Kalp Nath  
Rai.

SHRI ATAL BIHARI VAJPAYEE: ...who  
was in Allahabad for many years and he has  
given his own version of Mr. Palkhivala's  
speech. Sir, he spoke on the new birth of  
freedom in India.

*(Interruptions)*

SHRI ANANT PRASAD SHARMA: That  
is the point.

SHRI ATAL BIHARI VAJPAYEE: I have  
a gist of his speech. Sir, he condemned the  
proclamation of emergency... *(Interruptions)*.  
...and he castigated those who were  
instrumental in imposing the emergency in  
India.

*(Interruptions)*

SHRI KALP NATH RAI: Is it fair?  
*(Interruptions)*. It is unfair.

*(Interruptions)*

SHRI BHUPESH GUPTA: Sir, Mr.  
Palkhivala, if I may say so...

*(Interruptions)*

SHRI N. K. P. SALVE (Maharashtra) : Sir,  
just hear me... *(Interruptions)*. Please listen  
to me, Sir.

... , *(Interruptions)*

SHRI ANANT PRASAD SHARMA: Mr.  
Chairman, Sir, the honourable Minister has  
now come out with the statement that the gist  
of his speech is with him. So, please ask him  
to place it on the Table of the House.

*(Interruptions)*

SHRIMATI MARGARET ALVA:  
(Karnataka): Sir, he has said that the gist is  
with him.

*(Interruptions)*

SHRI N. K. P. SALVE: Sir, . . .

MR. CHAIRMAN: One minute, Mr. Salve.  
Mrs. Alva, according to you...

*(Interruptions)*

SHRI BHUPESH GUPTA: Mr. Palkhivala  
should have gone to lift the shoes of a lady .  
.

*(Interruptions)*

MR. CHAIRMAN: Just one minute.  
*(Interruptions)*. One minute, please. Now,  
according to the views of the honourable lady  
Member..... *(Interruptions)*. .he is coming out  
with something, Mr. Bhupesh Gupta, ac-  
cording to your statement, he is coming out  
with something. So, why not hear him?

*(Interruptions)*

SHRI ANANT PRASAD SHARMA: We  
are hearing him, Sir.

SOME HON. MEMBERS: Sir, we are  
hearing him.

PROP. N. G. RANGA (Andhra Pradesh):  
Sir, what we have been asking for is a copy of  
that speech. It has been the practice in both  
the Houses Sir, that the Chair, the Presiding  
Officer, has ruled, has always ruled, whenever  
a question is given notice of, is given due  
notice of, that the speech concerned, when it  
is made, by any one of the important func-  
tionaries of the Government whether

[Prof. N. G. Ranga] a Minister or an Ambassador or anybody else, when a demand has been made that the speech must be placed on the Table of the House, it has been the custom, it has been considered to be the duty of the presiding officer...

(Interruptions)

SHRI JAGJIT SINGH ANAND: It makes it incumbent on the Minister...

(Interruptions)

SHRI N. G. RANGA: You have authority, according to the practice, to insist that the report should be placed on the Table of the House. The Leader of the Opposition has asked you, but you were not good enough \_\_\_\_\_

(Interruptions).

SHRI JAGJIT SINGH ANAND: He should not have come to the House without the text... (Interruptions). You direct him to bring the text...

(Interruptions)

श्री कमलापति त्रिपाठी : आपके पास जो है वह रख लीजिये ।

श्री अटल बिहारी वाजपेयी : श्रीमान्, मैं सदन को आश्वासन देना चाहता हूँ और विरोधी दल के वरिष्ठ नेता को कि अगर मेरे पास उस भाषण की प्रतिलिपि होती तो मैं जरूर सभा पटल पर रखता ।

श्री कमलापति त्रिपाठी : आप जिसकी चर्चा अभी कर रहे हैं उसको...

श्री अटल बिहारी वाजपेयी : मैंने कहा उस भाषण का निचोड़...

(Interruptions)

श्री अनन्त प्रसाद शर्मा : निचोड़ रखिये...

(Interruptions)

श्री कमलापति त्रिपाठी : विदेश मंत्री जी... (Interruptions). मान्यवर, अभी विदेश मंत्री जी जिक्र कर रहे हैं कि...

(Interruptions)

DR. BHAI MAHAVIR: Let that gist be read out for the benefit of hon. Members...

(Interruptions)

SHRI JAGJIT SINGH ANAND: What is this?

(Interruptions)

SHRI ATAL BIHARI VAJPAYEE: I do not have a copy of the speech.

(Interruptions)

SHRI JAGJIT SINGH ANAND: He may be directed to get a copy of the speech. Let us take notes on this...

(Interruptions)

SHRI PRANAB MUKHERJEE: Let him give an assurance that he will give it...

(Interruptions)

SHRI N. K. P. SALVE: Mr. Vajpayee has admitted that he has got a gist of the speech with him. The issue is two-fold: first, when he has a gist of the speech with him, he should have divulged to the House what precisely Mr. Palkhiwala said in his speech; secondly, something which is far more important; is it fair and proper because there are certain well-known norms of international diplomacy, and no diplomat of any country gets involved in any controversial matter. His job is supposed to be something else. In the circumstances, Sir, is it fair and proper on the part of the Government, this incompetent Government, to use a manlike Mr. Palkhiwala to aggrandise and subserve the interests of the party in the U.S.A. and wash the dirty linen...

(Interruptions).

DR. RAFIQ ZAKARIA (Maharashtra):  
On a point of order...

(Interruptions)

SHRI N. K. P. SALVE: You have...

(Interruptions)

MR. CHAIRMAN: Mr. Salve, we are not  
discussing the subject today.

श्री कमलापति त्रिपाठी : अभी आपने  
कहा । अभी मंत्री महोदय ने कहा निचाड़  
है । आप उसे ही रख दीजिये ।

SHRI N. K. P. SALVE: You have listened  
to Shri Bhupesh Gupta. You have listened to  
others. This is a matter which concerns the  
rights of the House...

(Interruptions)

MR. CHAIRMAN: This shall not go on  
record.

(Shri N. K. P. Salve continued to speak)

MR. CHAIRMAN: It is not being  
recorded. Why do you go on speaking?

(Interruptions)

(Shri N. K. P. Salve continued to speak)

DR. BHAI MAHAVIR: Does he have the  
right to defy the Chair all the time?

(Interruptions)

MR. CHAIRMAN: I cannot compel any  
Minister to answer a question in a manner in  
which the Members desire. This is clear.  
(Interruptions) You are talking. But you are  
not allowing me to talk. Is it the way? My  
point is that he is clear in his mind that there  
is no copy of the speech. (Interruptions) You  
are not allowing me to speak. The point is that  
when the Presiding Officer has to do  
something, he must do it correctly. The  
Minister says that he has not got a copy of the  
speech. That was not a prepared speech.  
It was

an extempore speech. He has got no  
copy. I cannot compel him.

(Interruptions)

SHRI ANANT PRASAD SHARMA: The  
gist of the speech is available with the hon.  
Minister. That should be made available to  
us.

DR. RAFIQ ZAKARIA: I respect your  
ruling. You are right in saying that the  
Minister has said that he has not got a copy  
of the speech and, therefore, he cannot place  
it on the Table of the House. But he has  
contradicted himself by his subsequent  
behaviour. When Mr. Kalp Nath Rai  
made the allegations, he said that he did not  
know anything and, therefore, he could not say  
anything. Sir, my point of order is this. When  
he was asked for a copy of the speech, he could  
have told the Ambassador that even if he did  
not have a copy, he could recollect what he  
had said. The Ambassador could give a  
gist of what was said and that should have been  
placed on the Table of the House. He is just  
trying to take cover which is making it rather  
suspicious. If there was nothing objectionable  
in what the Ambassador did or which the  
Foreign Minister thought was not  
objectionable, he could have come forward  
and said that though he did not make a pre-  
pared speech and there was no verbatim  
version kept, still that was what he had  
said. I do not think there is anything  
objectionable in doing it. Firstly, he tried to  
evade a reply to that question. Then he  
says that no record was kept. Sir, it is your  
duty as the custodian of the rights and  
privileges of the Members to direct him  
because he himself has indeed admitted that  
he has the gist. (Interruptions) He said  
various things. But why did he not say that he  
was trying to get the gist? I want your  
ruling on this. (Interruptions) Sir, when a  
point of order is raised, it is your duty to  
reply to it or to say that it is irrelevant or  
out of order. The Foreign Minister in his  
own reply has

[Shri Rafiq Zakana] contradicted his own position. Firstly he said that he did not know anything and subsequently he came forward to say that he knew what was said.

*(Interruptions)*

SHRI S. W. DHABE (Maharashtra) : Sir, he has raised a point of order. Let it be replied. It is essential.

SHRI BHUPESH GUPTA: Sir, the point at issue is...

SHRI S. W. DHABE: Mr. Chairman, Sir, you are not protecting the House. Mr. Zakaria has raised a point of order.

MR. CHAIRMAN: Yes, I will give a ruling.

SHRI S. W. DHABE: Sir, you give us a ruling. And you must protect the House and not the Minister. *(Interruptions)*

MR. CHAIRMAN: How can I say if you all get up? I will find out from the record whether there is any contradiction between the earlier speech...

*(Interruptions)*

SHRI ANANT PRASAD SHARMA: Let the Minister deny that he has not said that the gist of a speech is with him. Let him deny.

SHRI ATAL BIHARI VAJPAYEE: There is no question of my denying. I did say that when the pamphlet was circulated, the Ambassador was contacted. And he informed the Ministry about his speech. He gave a gist of that speech.

*(Interruptions)*

SHRI JAGJIT SINGH ANAND: You should have laid it on the Table.

श्री कमलापति त्रिपाठी : आपसे मेरा निवेदन है मान्यवर कि विदेश मंत्री जी के पास जो निचोड़ है उनकी स्पीच का और जब इन्होंने पूछा था कि जो कुछ निचोड़

SHRI JAGJIT SINGH ANAND: During the Question Hour, he wasted half an hour. He should have placed the gist on the Table then.

*(Interruptions)*

MR. CHAIRMAN: When the Minister is prepared to say something, you are not prepared to hear. How can we carry on like this?

SHRI JAGJIT SINGH ANAND: Sir, he is shifting the ground.

श्री अटल बिहारी वाजपेयी : ... *(Interruptions)*. फिर कहा कि आप उसको सभा पटल पर रख दीजिये।

SHRI ATAL BIHARI VAJPAYEE: Sir, I am prepared to lay a copy of the gist of the speech on the Table and that will be done on Monday.

MR. CHAIRMAN: Mr. Kalap Nath Rai, as a Member of the Rajya Sabha, cannot lay it on the Table of the House. If at all he wants to lay it on the Table, it has to be sent through me. He cannot do it.
