(c) if not, what are the reasons therefor and what steps Government propose to take to ensure due representation to the cooperative sector for fan- distribution of coal and to stop malpractices by traders?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) The Delhi Administration issue retail coal licences in different areas, keeping in view the population of the area. Normally, they issue one coal licence for 1000 house-holds.

- (b) There are six cooperative stores holding i.-etail coal licences.
- (c) The Delhi Administration give preference to the cooperative sector over private applicants, whenever they apply for retail coal licence.
