(c) if not, what are the reasons therefor and what steps Government propose to take to ensure due representation to the cooperative sector for fair distribution of coal and to stop malpractices by traders?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): The Delhi Administration issue retail coal licences in different areas, keeping in view the population of the area. Normally, they issue one coal licence for 1000 house-holds.

- (b) There are six cooperative stores holding retail coal licences.
- (c) The Deini Administration give preference to the cooperative sector over private applicants, whenever they apply for retail coal licence.
