**REQUEST FOR PASSING OF THE
PAYMENT OF BONUS (AMEND-
MENT) BILL, 1978 AND THE SUGAR
UNDERTAKINGS (TAKING OVER
OF MANAGEMENT) BILL, 1978**

SHRI BHUPESH GUPTA (West Bengal): Sir, I have a submission to make before you leave. I have also written to you about this. I understand that there is a plan to extend the House till Tuesday. I am not commenting on that, but we have taken the steps, and rightly so, that these two motions standing in my name and in the name of Shri Bipinpal Das should be discussed. The Government has no other business. In fact, the Government cannot produce any sanctioned business before the House.

Here, Sir, we have a little problem and it seems the Government is putting us in the dock because of the two Bills—one is the Payment of Bonus (Amendment) Bill, 1978 and the other is the Sugar Undertakings (Taking Over of Management) Bill, 1978. These two Bills are in the interest of the working people, workers, employees and sugarcane growers. We are interested in passing them. We do not require a kisan rally for

passing these Bills over here. We can pass them here ourselves. We want them to be passed. Therefore, my suggestion is unless they want it for sabotage and also for propaganda purposes. Sir, you can make a rule and in one minute, just now, these Bills can be passed. Let the Government move the Bills. We assure you, Sir, that we shall not make any speeches and they can be passed now itself. After the passing of the two Bills, other things can be taken up. Therefore, as far as we are concerned, we are dead earnest about passing of everything which is in the interest of the working people. Sir, if they want to blackmail us by withholding these Bills, you can protect us. Let the country know that we are second to none in passing these two Bills. In fact, these are the result of the peoples' movement. We respect the peoples' movement. The Bills are just. The Bills have been circulated to us, but I do not know where the Ministers have disappeared. No difficulty, Mr. Ram Kripal Sinha can get up and say: "I move the Bill." One after the other the Bills will be passed.

SHRI YOGENDRA SHARMA (Bihar): They are not interested in passing.

SHRI BHUPESH GUPTA: That is my fear. Then they will propagate through the All India Radio that the opposition did not allow the Bonus Bill to be passed and the Sugar Undertakings Bill to be passed. For the All India Radio propagandists you should not allow . . .

SHRI ANANT PRASAD SHARMA (Bihar): Yesterday the All India Radio broadcast Mr. Advani's speech only, and nothing else.

SHRI BHUPESH GUPTA: We all agree, although we are compromising. As far as the Government is concerned, we are compromising here, but we are doing so in the paramount interest of our people.
