Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that Ministry of HRD every year sponsors/sends large number of students/ academicians abroad to reputed Educational

Institutions by awarding scholarships/fellowships under the Cultural Exchange Programmes;

(b) if so, the year-wise number of students/academicians sponsored/sent abroad under the above referred Programs during the last five year;

(c) the number of persons belonging to SC/ST categories among them and their percentage, as compared to the total number; and

(d) whether adequate number of persons belonging to the SCs/STs are not sponsored/sent; if so, the reasons therefor?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) A limited number of students, as finally selected by the donor countries, on the basis of a list prepared by us, go abroad each year under the Cultural Exchange Programs.
