THE MINISTER OF EDUCATION. SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUN-DER): Sir, according to information furnished by the Education Department, Government of Uttar Pradesh, Aided Higher Secondary Teachers' Association gave a notice on 18th November, 1977 for strike call with effect from December 2. 1977 in case their demands were not met. The State Government discussed various demands with the representatives of the Association and agreed to actively consider most of them. It is understood that there are about 21 demands. Some of the main demands of the Association are as follows:---

- (i) Non-Govt. Private Higher Secondary Schools should be nationalised and private management system should be abolished:
- (ii) Education should not be removed from the Concurrent List;
- (iii) Ad hoc payment of Rs. 150/per month be sanctioned pending decision on the National Wage Policy; and
- (iv) An Educational Service Commission should be set up.

Notwithstanding the assurance of the U.P. Government that they would consider various demands actively, the representatives of the Association took the
