**Unprecedented Havoc Caused By  
Recent Cyclone in Tamil Nadu  
and Pondicherry**

SHRI V. V. SWAMINATHAN (Tamil Nadu) : Sir, I call the attention of the hon. Minister of Agriculture and Irrigation to the unprecedented havoc caused by the recent cyclone in Tamil Nadu and Pondicherry resulting in heavy loss of human life and damage to crops and property.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH) : Sir, in accordance with the information obtained from the State Government of Tamil Nadu and the Administration of the Union Territory of Pondicherry, the position is as follows :—
