##### **Reporter recent Incidents of murders and dacoities in and around Delhi —and steps taken by Government**

MR. CHAIRMAN: Calling Attention to Matter of Urgent Public Importance. Shrimati Ambika Soni.

SHRI G. LAKSHMANAN (Tamil Nadu): Sir, I want to raise a very important issue.

SHRIMATI AMBIKA SONI (Punjab) : Mr. Chairman, Sir, the matter which I want to bring to the notice of the House is. ...

SHRIMATI AMBIKA SONI: I would like to call the attention of the Minister of Home Affairs to a matter which is of very grave concern not only to the Members of this House and the other House but to all the peace-loving citizens of Delhi.

MR. CHAIRMAN: You need not make a statement now. The Minister will read a statement. Then you will have to make your points.

SHRIMATI AMBIKA SONI: Sir, I beg to call the attention of the Minister of Home Affairs to the recent incidents of murders and dacoities in and around Delhi and the steps taken by Government in this regard.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS ( SHRI S. D. PATIL): Sir, in the Calling Attention Notice reference has been made to the recent incidents of murders and dacoities in Delhi. Presumably, it relates to the two incidents which took place recently, one on the night of 11th December, 1977, at No. 1, South End Road, New Delhi, when two persons were killed and another sustained serious injuries to which she eventually succumbed and the second to the robbery in three houses on the night of the 14th December, 1977 by an armed gang near village Dabri, in the area of Police Station, Delhi Cantt. In the first case the police reached the spot within few minutes of receipt of the-
