Besides, some institutions receive financiil assistance from W.H.O, with prior concurrence of the Government of India for research work in this field.

There is no separate amount specifically provided for research work in oral contraceptives in these institutions.

978. SHRI NAGESHWAR PRASAD SHAHI: WiH the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

- (,a) whether it is a fact that the Madan Mohan Malviya Engineering College. Gorakhpur in U.P. sought the Central Governments permission about seven years ago to start post-graduate courses;
- (b) whether it is also a fact that the Central Government agreed to/ send a visiting committee and also issued a letter to that -ut the visiting cmmittee has not yet gone there; and
 - (c) if so, what are Ihe reasons there--for?

THE MINISTER OF EDUCATION. SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUN-DER): (a) to (c) Yes, Sir. The Northern Regional Office of the Ministry of Education and Social Welfare had appoint-d a Committee to viait the Madan Mohan Malviya Engineer-College, Gorakhpur and other institutions which had submitted proposals for starting post-graduate courses. Meanwhile, the Post-Graduate Board which met on 5th July 1971 resolved that before sanctioning new post-graduate courses, . the existing post-graduate courses should be reviewed. Therefore, the Committee could not visit the College and the College was informed accordingly in 1971. On the recommendations of the task force appointed to review post-graduate courses, the Post-Graduate Board decided that new post-graduate courses should be established only in relevant areas depending on their demand. Subsequently, a Screening Committee examined all the pending proposals. The proposal of the Madam Mohan Malviya Engineering College has not been supported by the Screening Committee.
