have taken to protect their pay and seniority?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a) and (b) Consistently with the Government's intention to progressively wind up sections of the Department as and when the assigned item of work contracts or gets completed, 24 employees out of the 690 existing as on 1-5-1978 have been so far either absorbed in other Ministries and Departments or adjusted in the Department of Rehabilitation itself and the Department has 666 emplovees as on 30-11-1978.

(c) The employees of the Department as and when rendered surplus will be considered for appropriate absorption elsewhere, their pay and seniority being governed by the applicable rules.

Master Plan for North Bengal Rivers

The Plan is yet to be considered by the I: Consultants of the North Ben Control Commission and ! by the Commission before the Sun Government approves and subraits the same to the Centre.
