**THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI JAGDAMBI PRASAD YADAV):** (a) and (b) No such instructions have been issued by the Government of India.

**Subsidy to cashew plantations**
