## Trains without guards and brake-vans

- 1167. SHRI F. M. KHAN: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government are aware that trains are being rui on many sec tions without guards and break-vans resulting in thefts and pilferage, and
- (b) if so, whether Government pro pose to enquire into the responsibility of officials in this matter for thus aid ing and abetting thefts of railway pro perty?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN); (a) Trains are not normally run without guards or brake-vans. Under special instructions however, trains can be run without guards or break vans in inescapable circumstances, which is permissible under the extent rules. Adequate precautions are taken in such cases to prevent thefts and pilferages.

## Direct recruitment of technical posts >on the Southern Railway

1169. SHRI ANANDA PATHAK: Will the Minister of RAILWAYS be pleased to stae:

- (a) the number of posts of Telecom munication Maintainer (Trainees), Wireless Instrument Mechanics and Electrical Signal Maintainers on the Sourther Railway at present for which direct recruitment, has been prescribed under the rules category-wise and Divi sion-wise; and
- (b) the reasons for not filling up the vacancies by direct recruits for the last several years?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) and (b). A provision exists for filling up 50 per cent of the vacancies in the category of Telecom Maintainers, Wireless Mechanics and Electrical Signal Maintainers in scale of Rs. 260-400 by direct recruitment. As these are artisan categories, direct recruitment is resorted to only after trade testing and promoting all eligible staff in lower grades. In Mysore Division of Southern Railway 5 posts of Telecom Maintainers that fell vacant recently, chanics and 2 of Electrical Signal Maintainers that fell vvacant recently, have been earmarked for direct recruitment. Action is being taken to fill these vacancies.
