foreign countries, and, if not, whether the Government is prepared to consider the proposal for giving equal opportunities to these categories of persons so that they may also feel equal with other people belonging to advanced aⁿd developed communities and thus strengthen national integrity?

DR. PRATAP CHANDRA CHUN-DER: As I said, selection is made on the basis of merit and talent. In these cases we do not proceed on the basis of caste or backwardness.

DR. BHAI MAHAVIR: In view of the need which the honourable Minister has emphasised for proper values and proper image of the country being presented outside, I wish to ask the Minister if any orientation course is conducted before such members are selected for cultural delegations^There were instances in the past of certain people being caught in shop-lifting and being hauled up before the Magistrates. If such things happen, the fair name of the country is sullied. In this connection, I wish to ask him if his attention has been drawn to a press report titled . . .

MR. CHAIRMAN: Thi_s will not arise out of this question.

DR. BHAI MAHAVIR: How? I_n the issue of Sunday dated the 10th December ...

MR. CHAIRMAN: This will not arise.

SHRI DINESH GOSWAMI: May I know from the hon. Minister whether it is a fact that a sponsor from South Africa is trying to get a team of talented artistes from here to that country and if so what is the Government's reaction to this? Is it a fact that Assam and Tripura where the folk music is very popular are being totally neglected while choosing these cultural delegations?
