 - (2) Commission on net outward freight—5 per cent $(2\frac{1}{2}$ per cent for booking and $2\frac{1}{2}$ per cent for servicing).
 - (3) Commission on import cargo:
 - (a) General cargo

 - . 37 paise per DWT.

(4) For bulk carriers and tankers loading/or discharging.

- (c) what is the amount paid to them during the last three years, year-wise?

THE MINISTER OF STATE IN CHARGE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI CHAND RAM): (a) Yes, Sir.

(b) and (c) A statement is attached.

Statement

- (b) The details are as follows:
- (i) Agency fees per call per Port-Rs 225/-
- (ii) Commission on net outward freight—5 per cent of freight charges (2½ per cent for booking and 2½ per cent for servicing).
 - (iii) Commission on import cargo:
 - (a) General cargo—50 paise per DWT.
 - (b) Bagged cargo—37 paise per DWT.
 - (c) Bulk cargo—25 paise per ton or 1500 rupees whichever is less.
- (iv) For Bulk Carriers and Tankers loading and/or discharging.

The fees payable are on lumpsum basis depending on tonnage of cargo to be discharged or loaded and range from 1250 rupees to a maximum of 3000 rupees per call.

- (v) For passenger vessels they are paid a commission of 7 per cent on saloon passenger fares and 5 per cent on dormitory and bunk class passenger fares on tickets sold by them.
- (vi) M/s. K. P. V. Shaik Mohamed Routher and Co. Pvt. Ltd. (KPVS) are also SCI's contractors for stevedoring at Madras for which they are paid a per ton rate, depending upon the commodity
 - (vii) M/s. Shaik Mohamed Routher and Co. Pvt. Ltd., are also victualling contractors of SCI for their passenger vessels plying between Madras and Singapore—

The rates paid to them are as follows:—

1. Cabin Class Passengers...

Rs. 30.73/Day.

2. Dormitory Passengers..

Rs. 18.60/Day.

3. Bunk/Deck Passengers...

Rs. 16.80/Day.
