A study has since been undertaken and pending completion of the study, some additional posts have recently been sanctioned on an ad hoc basis to provide immediate relief.]

(b) whether it is also a fact that parcels, though shown in hand in the delivery books, have actually been found missing without any report having been made to the police by the supervisory staff; and

(c) if so, what action Government have taken against the employees concerned to avoid a recurrence of such cases i_n future?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE), (a) to (c). A statement i_s laid on the Table of the House.

Statement

During investigations made by the Vigilance Inspectors of Northern Railway from 1-9-78 to 30-11-78. 26 instances of irregularities in loading of hard parcels/luggage by restricted trains were detected. No case of short remittance of Government cash came to notice during these investigations.

Since 1st September^ 1978, no parcels shown in hand in the delivery books, have been found missing without any report having been made to the police by the supervisory staff.

In regard to irregularities detected in the loading of hard parcels/ luggage, disciplinary action is being taken against 13 employees of New Delhi Railway Station against whom *prima facie* charges have been established.
