#### Credit for Electrification

1560. PROF. RAMLAL PARIKH: Will the Minister of FINANCE be pleased to state:

- (a) whether the Central Government are aware that a large number of villages in Gujarat are deprived of credit facilities for electrification due to the norms prescribed by the Reserve Bank of India:
- (b) if so, what are the details thereof; and
- (c) whether Government propose to review the norms laid down in this regard to cover more villages for electrification?

THE MINISTER OF FINANCE (SHRI H. M. PATEL): (a) and (b) Presumably the Hon'ble Member is referring to the norms for regulation of term loans provided by Land Development Banks for various purposes including those of energisation of pumpsets. The eligibility for making advances by Land Development Banks is linked with their recovery performance according to the following formula:—

In Gujarat State out of 182 branches of State Land Development Banks 119 branches have no eligibility, 60 branches have restricted eligibility and three branches have unrestricted eligibility for making advances during 1978-79.

(c) The overdues criteria operative at present has been reviewed and will be replaced soon by a revised formula.

### Head Offices of the State Bank of India

1561. SHRI AJIT KUMAR SHAR-MA: Will the Minister of FINANCE be pleased to state:

- (a) the number and location of the Head Offices of the State Bank of India; and
- (b) by when new Head Offices are likely to be opened at Gauhati, Bhubaneswar, Chandigarh and Bangalore?

THE MINISTER OF FINANCE (SHRI H. M. PATEL): (a) At present, the State Bank of India have nine local Head Offices located respectively at Ahmedabad, Bhopal, Bombay, Calcutta, Hyderabad, Kanpur, Madras, New Delhi and Patna.

(b) The State Bank have decided to open local Head Offices at Bhubneswar and Chandigarh soon. But, no date for their opening has been fixed. As

for the establishment of local Head Offices at Gauhati and Bangalore no decision has been taken.

# Ban on Bank Advances to Industrialists evading Payment of Income Tax

THE MINISTER OF FINANCE (SHRI H. M. PATEL): (a) and (b) Government are seized of the question of devising measures aimed at economic offenders which would be an effective deterrent without causing any adverse economic consequences to the society. It is premature to give details in this regard.

## Conversion of the Ahmedabad Airport as an International Airport

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE, CIVIL SUPPLIES AND COOPERATION (SHRI ARIF BEG). (a) Export of Basmati rice is allowed on open general licence and Minimum Export Price has been fixed with effect from 4th August, 1978 as under:—

(Rs. per tonne)

Polished Basmati rice ... 5500 Dehusked non-polished rice ... ... 5000

Paddy rice ..... 5000

(b) Basmati rice is normally not part of the staple diet of the common man in India and its export does not have much impact on the prices of the
