THE MINISTER OF FINANCE (SHRI H. M. PATEL): (a) to (c) The findings of the Committee on Public Undertakings make in their 10th Report on "Unusually high expenditure by Public Undertakings for their Head offices" are still under consideration by Government.

However, guidelines have been issued to the Public Enterprises on Economy in cost of maintenance and administration of townships in Public Sector Enterprises.

Dearth of aircraft maintenance engineers

1488. SHRI R. R. MORARKA: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether there is a dearth of ai' craft maintenance engineers causing serious problems to tb<* Air India maintenance flight, due to their accepting lucrative jobs in West Asian airlines:
- (b) if so, what steps are propose' to be taken to overcome this difficulty; and
- (c) whether any embargo is contemplated on this brain drain?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOTTAM KAUSHIK): (a) There has been some shortage of Aircraft Maintenance Engineers in Air India due to /experienced and senior engineers leaving Air India for joining other Airlines. This shortage has resulted in some delay to Air India's flights, but there have been no serious maintenance problems.

(b) Mass recruitment and intensive training programmes have been undertaken by Air India to recruit and train engineers. They have also approached the airlines neigh-
