- 19. The Government has set up a Society by the name of Bhartiya Yatri Avas Vikas Samiti to raise and administer funds for the maintenance/expansion/construction of dharamshalas/sarais/musafirkhanas.
- 20. Organisation of special cultural programmes, son-et-lumiere spectacles, and package tours for travel within India generally or to specific places are yet some other facilities provided to attract more international tourists to the country.

The Ajman Arab Bank. Dubai stopped tions in May 1977 due to certain financial difficulties. Efforts are, however, being made with the help of the United Arab Emirate's Currency Board to restart the bank under a new management and the Bank of Baroda expects that its deposits will then be repaid under the scheme of repayment including rescheduling.

- (b) whether it is a fact that the import of these items in the country without payment of customs duty adversely affects the growth of the indigenous industry; and
- (c) if so, whether Government propose to restrict the import of such tape recorders by not treating the same as personal baggage as has been done i the case of television sets?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SATISH AGARWAL): (a) Under the Baggage Rules only such radios and cassette tape recorders are allowed free of duty as are not in combination with each other or with any other sound recording/reproducing articles Radios, tape recorders, record players etc. which are in combination commen ly known as two-in-one or three-in-one, are not allowed free of duty under the Baggage Rules.

- (b) There is no significant import as baggage, of radios or cassette tape recorders which are not in combination There is no adverse effect, therefore, on the growth of the indigenous industry. The indigenous industry is, in any case, reported to be recording satisfactory continuing growth over the years.
- (c) In view of (b) above, the question does not arise.
