Computer education in Schools

657. SHRI E.M. SUDARSANA NATCHIAPPAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) how many Government run schools have introduced computer education in their curriculum during the last two years in different parts of the country; and
- (b) what steps are being taken by Government to increase computer proficiency rapidly in different parts of the country?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI M.A.A. FATMI): (a) The Department of secondary and Higher Education introduced a revised Computer Literacy and Studies in Schools (CLASS) scheme in 2001-2002 to promote computer literacy in schools in the country. Under the revised CLASS scheme, financial assistance has been provided to 19 States/U.Ts. since 2001-2002, for covering 3112 Govt, and Govt, aided schools.

(b) A new scheme titled "Information and Communication Technology (ICT) @ Schools", has been introduced during 2004-05. Revised CLASS scheme has been merged in the new ICT @ schools scheme. Under the ICT @ Schools scheme, financial assistance would be released to the States/U.Ts. for imparting computer education in Government and Government-aided Secondary and Sr. Secondary schools during the 10th Plan.

Foreign Direct Investment in Education

- (a) whether there is any proposal for Foreign Direct Investment (FDI) in education;

FATMI): (a) to (c) Foreign Direct Investment in Education covering all sectors is allowed under the autpmatic route without any sectoral cap. Investors may choose to make an application to FIPB and not avail the automatic route. Proposals coming under FIPB are referred to this Department for comments by the Department of Industrial Policy & Promotion. A company-wise list of proposls approved for the period from January, 2002 to December, 2004, involving Rs. 32.06 crore is given in the Statement (See below).
