THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a) There are no general pool quarters at 'G' point. There are 100 quarters of the President's Secretariat Pool and some quarters of the Posts & Telegraph Department Pool, details of which are not readily available.

- (b) These quarters are likely to be demolished in due course for purpose of re-development.
 - (c) The question does not arise.
- (d) and (e) No, Sir. Development work in the adjoining areas is going on. Some quarters have already been constructed; more quarters are under construction and further construction is likely to be taken up shortly.
