t[THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH); (a) The Government of India have oeen providing assistance to State Governments under specific schemes for the cooperative sector. The nature of schemes and the quantum of assistance to be given during tha Five Year Plan (1978-83) is currently under discussion with the Planning Commission. A final decision i? likely to be taken only after the National Development Council takes a view on the nature and scope of schemes of Central Assistance to be given tc the States.

(b) A number of schemes started during the Fifth Plan are continuing during the current year. Some of these schemese are applicable only to some States e.g. cooperatively weaker States. In some cases, assistance is related to the nature of the Cooperative institutions. However, information regarding assistance so far released to various States under ongoing schemes is given in the Statement I to IV enclosed. There are also other schemes of assistance to cooperatives which are under the Department of Civil Supplies & Cooperation in the Ministry of Commerce. Civil Supplies & Cooperation. Statewise assistance given undei- these schemes is in statement V. [See Appendix CVII, Annexure 96]

Rise in prices of wheat and pulses

1680-C. SHRI SAWAISINGH SISODIA: SHRIMATI HAMIDA HABIBULLAH: SHRI PRAKASH MEH-ROTRA: SHRI N. G. TOMPOK SINGH:

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether there has been an increase in the prices of wheat and pulses during the last few months;

(b) if so, what are the varieties affected thereby; and

(c) what steps have been taken by Government to control their prices?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH): (a) and (b) Yes, Sir. The price indices of wheat and pulses were higher on 18th November than what they were on 1st July. The increase in the case of wheat is due to seasonal variations in supplies and in the case of pulses due to stagnation in production. The index of urad pulse was, however, constant.

(c) Efforts are being made to increase the production of pulses by increasing the area under pulses and also by improving productivity. Import of pulses has bean placed on Open General Licence (OGL) since April, 1978. As regards wheat and wheat products, all restrictions on movement of these commodities have been removed so that sufficient quantities are available in the open market. Government are also meeting fully the requirements of the State Governments for distribution of wheat and rice through the Public Distribution System at subsidised prices
