- (b) Mechanised trawlers and countryboats operate different types of gear. While mechanised boats trawl for bottom fishes, particularly prawn, mostly during the day, the traditional boats operate gillnets, cast-nets, drag-nets, stake-nets, etc. during the night or early morning hours. Reports of conflict between mechanised boats and countryboats have been received from some areas. There is no evidence to show that operation of mechanised trawlers disturb the ecological balance of the sea.
- (c) As the requisite legislation would involve regulation of operations within the Territorial Waters, it is considered legally advisable that such legislation should be enacted by the State Legislature. The Governments of Coastal States have been advised to enact the law for regulating operation of fishing crafts of different types. It is proposed to send a model bill to the States.
