(b) if so, what steps Government have taken to prevent black-marketing ia tickets during the forthcoming International Film Festival to be held in Delhi in January?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI LAL K. ADVANI): (a) Government has not received any comp-laint, for the last International Film' Festival which was held in January, 1977.

(b) Government have taken various measures to ensure that there is no misuse of tickets and the hardships to the public during the forthcoming International Film Festival being held from January 3 to January 17, 1979. These measures which were tried and found effective in Filmotsav '78 includes; (1) All tickets are being stamped before sale by the Entertainment Tax Authorities and the Management. No ticket will be sold or considered valid without these stamps. (2) A season ticket will not be valid if it is not presented along with the season ticket book to ensure that there is no misuse of individual ticket for a particular show. (3) Sale of tickets is being limited to two tickets per person. (4) Information with regard to the exact number of tickets available at a particular theatre in different denominations wiU be displayed at every Festival theatre. (5) Senior Officers of the Festival Management will be present at the ticket sale booths to supervise the sale of tickets to the public.
