THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDILA CHUN-DER): (a) and (b) Financial assistance is given to groups of performing artists under the following Schemes:-

- (i) Financial Assistance to Dance-Drama and Theatre Ensembles. This scheme is administered the Department of Culture. Under the Scheme, financial assistance is given to professional groups working in the field for more than 10 to 15 years to cover expenses towards salaries of artistes and cost of new productions.
- (ii) Scheme of grants to Cultural institutions working in the field of performing arts. This scheme is administered by the Sangeet Natak Akademi. Grants under the Scheme are given for some specific projects or for maintenance.
- (c) A statement giving the financial assistance granted to the institutions by the Department of Culture as well as the Sangeet Natak Akademi is enclosed. [See Appendix CVII, Annexure No. 14].
- (d) The main criteria are artistic excellence contribution to the field and the importance of the project.

# Token strike by the nurses in hospitals in Delhi

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMI-LY WELFARE (SHRI JAGDAMBI PRASAD YADAV): (a) and (b) Only the nurses under E.S.I. Hospital, Delhi. which is under the administrative control of Ministry of Labour, went on strike in September, 1978, to press their demand for the grant of Rs. 100/p.m. as E.S.I. allowance. As a result of intervention by the Deputy Chief Labour Commissioner and Conciliation Officer of the Government of India the strike was called off. No final decision has yet been taken in regard to the demand raised by the nurses.

# Fall in the sale of liquor in Delhi
