 - (i) Maximum speed limit for various types of vehicles has been reduced on different roads. Traffic police is making surprise checks for overspeeding and negligent driving and prosecuting the offenders. On an average 4 mobile courts conduct on the spot prosecution.
- (iii) Restrictions are being imposed on certain roads for loading of safety are conveyed through radio, T.V., cinema slides, lectures and by distribution of pamphlets.
 - (iii) Restrictions are being imposed on certain roads for loading and unloading and parking and making entry one way.
 - (iv) Efforts are also being made to widen and improve roads and to construct more cycle tracks.
