News-item regarding coal shortage

325. SHRI T. ANJIAH:

SHRI KALP NATH RAI: SHRI SHYAM LAL YADAV; SHRIMATI SAROJ KHAPARDE:

Will the Minister of ENERGY be pleased to state:

- (a) whether Government's attention has been drawn to the news item which appeared in the 'Indian Express'; of the 14th October, 1978 under the caption "coal shortage may put economy out of shape"; and
- (b) if so, what remedial steps Government have taken or propose to take in this regard?

THE MINISTER OF ENERGY (SHRI P. RAMACHANDRAN): (a) and (b) Yes, Sir.

A large number of underground and opencast mines in the Eastern Coalfields Ltd. and Bharat Coking "Coal Ltd. were drowned in the recent floods. Emergent steps were taken for procurement of pumps, cables and pipes needed for dewatering the drowned mines and already about 35 •of the drowned underground working districts and about 60 of the drowned quarries have been dewatered. The remaining drowned mines would aLso be recovered expeditiously.

Steps have been taken to augment production by intense working in the districts which have not been drowned, by opening new districts in areas not affected by floods and by expediting various schemes under implementation. For improving availability of coal to consumers despatches from stocks have been increased.
