Co. Ltd. and Indian General Navigation & Railwaj- Co. Ltd.—popularly known as Joint Steamer Companies) and not National River Steamship Co. prior to 1965 between Calcutta and Assam *via* erstwhile East Pakistan now Bangladesh, used to serve the major transport needs of the North eastern States.

(b) Central Inland Water Trans port Corporation Ltd., a Central Go vernment Undertaking is running ri ver transport services between (i) Calcutta and Gauhati; Cal and (ii) cutta and Karimganj, Bangladesh via The Corporation has also introduced integrated river-cum-road services Karimganj. between Calcutta and Agartala (Tripura) to serve the needs of these remote areas.

Increase in the prices of tyres and tubes

2W. SHRI SYED AHMAD HA-SjrTMI: SHRI SWAMI DINESH CHANDRA: SHRIMATI SUSHILA SHAN-KAR ADIVAREKAR:

Will the Minister of INDUSTRY be pleased to state:

(a) whether it is a fact that the prices of almost all types of automobile tyres and tubes have been raised for the fourth time during the current year;

(b) if so. how far the prices of different types and brands of tyres and tubes have been raised each time; and

(c) what are the reasons for raising the prices and what steps Govern ment propose to take to bring down the prices of these essential consumer items?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (KUMARI ABHA MAITI); (a) to (c) The tyre manufacturers raised

the prices of various categories of tyres and tubes in the last week of March, 1978. Subsequently also they increased the prices of automobile tyres and tubes. A statement showing the increase in whole-sale prices of automoible tyres and for the period from January, 1977 to October, 1978 is attached. [See Appendix CVII Annexure No. 19.] The tyre manufacturing companies have stated that they have been compelled to increase the prices of automobile tyres and tubas owing to increase in the cost of various inputs, higher cost of production and excise duty as well as financial problems faced by them. As there is no statutory control on prices of tyres and tubes, the tyre companies are not required to obtain Government's approval for the increase in prices.

Screening of smuggled foreign films

283. SHRI GHOUSE MOHIUDDIN SHEIKH: Will the Minister of IN-FORMATION AND BROADCASTING be pleased to state:

(a) whether Government are aware that some smuggled foreign films with forged certificates have been screened in some States during the lost three years; and

(b) if so, what is the number of such films screened and what action Government have taken in the matter?

LAL K. ADVANI): (a) and (b) One case of such violation came to the notice of the Board *of* Film Censors recently. With the help of the State Government the print of the film has been seized. The State Government has been requested to take further action in accordance with the provisions of law.
