#### **Rise in divorce cases**

4841. MS. PRAMILA BOHIDAR: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether there has been a rise in the cases of divorce during the last three years;
- (b) if so, the details of and the reasons therefor; and
- (c) what measures being taken to check such cases and provide relief to women divorcee?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KANTI SINGH): (a) and (b) As per the information furnished by the National Sample Survey Organisation (NSSO), under the Ministry of Statistics and Programme Implementation, there has been no significant increase in the number of women divorcees.

According to the information furnished, the number of divorced/separated women of the age of 10 years and above, has been as follows:

According to some expert opinion, divorce in most well to do families, both by males and females, is due to lack of adjustment and ego clashes. In the case of poor people divorce is initiated by the husband.

(c) The Department of Women and Child Development is implementing the following schemes to rehabilitate such women:

Swadhar: Under this scheme, marginalized women/girls living in difficult circumstances without any social and economic support are given the primary needs of shelter, food, clothing and care.

Short Stay Home for Women & Girls: Under this scheme, women and girls who are made to leave their homes due to family tension or discord and without any means of subsistence and have no social protection from exploitation or facing litigation on account of marital disputes are provided shelter, maintenance, medical care, vocational training etc.

ALI ASHRAF FATMI): (a) The Continuing Education Programme has been sanctioned for the districts of Bolangir, Kalahandi, Sundergarh and a special project for Rourkella. According to the reports received from State Government 1532 Continuing Education Centres and 163 Nodal Continuing Education Centres have been set up in these districts.
