Pro forma accounts for the year 1977-78 are under preparation.

- (b) While the Films Division's revenue receipts realised in the form of theatre rentais are not flexible to any great extent, its expenditure is increasing steadily due to higher cost of production as a result of increased prices of raw stock, processing charges, wages, etc., and a greater number of prints produced.

- (b) The rate of growth in industrial production during April—July, 1978 is higher at 8.2 per cent as compared to 4.2 per cent during the corresponding period of 1977-78;
- (c) The low rate of 3.9 per cent during 1977-78 was due to a number of factors such as (i) power cuts; (ii)

prolonged strikes/lock-outs in some major units; (iii) lack of demand/ (sufficient orders and shortage of certain critical components; and (iv) availability of cheaper substitutes.
