ber of the Karmahom Conference, are not available for the export of marine products. A certai'n minimum temperature at the time of loading frozen marine cargo if, necessary failing which the sea-food could deteriorate and become unacceptable t.o the consignees. Export of Sub-standaiy products would also harm our exports in the long ru'u. Some exporters in Bombay have not accepted the prescribed conditions. The matter is under review in consultation wi'h other authorities.

Victimization of the employees of POL **Department**

672. SHRI ANANDA PATHAK: Will the Minister of DEFENCE be pleased to state:

- (a) whether Government has received any representation regarding vindictive suspension and termination of services of a large number of employees of POL Department, Beng-chubi in the District of Darjeeling;

The facts of the case are that as a result of reduction in the work-load of the unit, 150 casual labourers, who had put in over 3 months' service, have been reendered surplus. However, 143 of them have already been provided alternative employment. No victimisation of any depot employee is involved and the question of grant of trade union rights does not arise.
