other supplementary. Does he want to add anything?

SHRI CHAND RAM; Sir, in fact, this question relates to rural roads and not to the national highways.

MR. CHAIRMAN: He says that the rural roads are connected with the national highways. From that point of view, is the Government considering anything?

SHRI CHAND RAM: The main question was regarding setting up of a Rural Road Commission and a Rural Road Construction Corporation. I replied that it was the States' responsibility, and that they did not agree to the setting up of the corporation.

SHRI SANAT KUMAR RAHA; Sir, in view of the new emphasis given by the Janata Party in their manifesto on rural development, I want to know from the Minister whether, as in the case of the national permit system, the Government, before setting up such a commission will give some comprehensive guidelines to the States so that this can be coordinated by the Centre.

SHRI CHAND RAM: It does not arise here. He is asking a question about the national permits.

SHRI SANAT KUMAR RAHA: No, no. I asked whether you would give comprehensive guidelines for the development of rural roads.

MR. CHAIRMAN: His supplementary is simple.

SHRI CHAND RAM: As I said, since the taking over of the administration by the Janata Party, the Janata Party, the Janata Government has allocated a sum of Rs. 20 crores for the first time, for the develoment of rural roads.

MR. CHAIRMAN; That was not the question. The point is whether the Government of India is interested in giving some guidelines.

SHRI SANAT KUMAR RAHA: Comprehensive guidelines.

SHRI CHAND RAM: There is an organisation under the Shipping...

SHRI N. G. RANGA; Are you giving guidelines?

SHRI CHAND RAM: Yes, we are issuing from time to time, we have been issuing. Our Director. . .

SHRI SANAT KUMAR RAHA: I am not asking about routine advice. I am asking whether from the Centre comprehensive guidelines will be issued in accordance with the new emphasis in the Janata Party manifesto on rural development so that rural development may be quickened.

SHRI CHAND RAM: That ultimately comes to the question of funds.

THE MINISTER OF STATE IN THE MINISTRY OF .HOME AFFAIRS (SHRI S. D. PATIL):. (a,) No arrangements for the funeral of Shri Jayaprakash Narayan were made by" Government of India. In November, 1975, when the condition of Shri Jayaprakash Narayan was causing anxiety, the Bihar Government had prepared a contingency plan for meeting the situation arising out of the unfortunate eventuality of his death on the presumption that his cremation would take place in Patna. ' Since it was anticipated that people in large numbers would like to pay their last homage to Shri Javaprakash Narayan, the contingency plan was prepared for orderly public participation in the funeral and ensuring the maintenance of law and order.

(b) Does not arise.

## Production targets of the Scooters India Ltd.

## to Questions

Will the Minister of INDUSTRY be pleased to state:

(a) whether the Scooter India Ltd., Lucknow has fixed any targets for the production of two wheeler' scooters and mopeds during the year 1977-78; and

(b) if so, what are the details thereof?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) and (b) The targets of production fixed for Scooters India Ltd. for the year 1977-78 were 60,000 twowheeler scooters; 5,000 three-wheelers and 12,000 mopeds. The performance during the period April to October, 1977 was much below the targetted levels owing to various factors including deficiencies in quality control. Remedial action has been taken and the production is expected to pick up appreciably during the period November 1977 to March 1978. On the basis of the pick up in production programmed during this period the revised targets fixed are 26,681 two-wheeler scooters; 15,030 power packs; 500 threewheelers and 3,500 mopeds.

SHRIMATI HAMIDA HABIBULLAH: It is most unfortunate that the target has fallen to such a low measure. I have not quite understood the reason for this great fall. 1 would like to ask the honourable Minister the reason for this fall and also why the target has been brought down under the present .circumstances, because we were hoping that the targets would go up instead of being brought down. From 60,000 announced 'by the Minister, the target for two-wheeler scooters has been brought down to 26.000: I think this is most unfortunate.

SHRI GEORGE FERNANDES: I entirely agree with the honourable Member that it is most unfortunate that the targets had to be lowered. The fact is that in the first half of this year this factory was not doing well There have been a number of problems, primarily the problem of
