- (b) if so, what are the reasons therefor; and
- (c) what steps Government propose to take to remedy the situation?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) No, Sir; During April-August 1977, the latest period for which full data are available,, the rate of growth of production was lower than last year, but substantially higher than the previous three years. Partial data for Septem. ber and October show more improvement in production rather than a gradual decline.

(b) and (c) Do not arise.

## Import of watches for marketing through H.M.T.

'720. DR. RAJAT KUMAR CHAKRABARTI: SHRI JAHARLAL BANERJEE: SHRI PHANINDRA NATH HANSDA;

Will the Minister of INDUSTRY be pleased to state;

- (a) whether it is a fact that Government are importing a large number of watches of reputed foreign brands for marketing through HMT:
- (b) whether Government propose to expand the HMT units all over the country to meet the demand of watches indigenously;
- (c) whether HMT propose to place orders with small scale units which are capable of manufacturing simple watch parts, like cases, dials, crown-screws, etc. in order of augment the manufacture of watches?

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) The present production capacity of HMT for manufacture of watches is not adequate to meet the demand. In order to increase the availability of HMT watches, Government have permitted imports of watches in aemi-knocked-down and completely-knocked-down conditions and whole

- watches. Whole watches will be imported only through H.M.T. and will bear the HMT's brand names and will not be distinguishable from HMT's indigenous production.
- (b) and (c) Government have sanctioned the augmentation of HMTs watch production by 2 million watches per year, envisaging the creation of a centralised watch manufacturing unit and 14 dispersed assembly units. The labour intensive operations will be done in these assembly units. Other labour intensive aspect, for instance, relating to case manufacture, will be formed out to small-scale ancillary industries.

## **Devolution of power to State Governments**
