THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI S. KUNDU): In accordance with its principled stand of total opposition to nuclear weapons, Government is against all kinds of proliferation of nuclear weapons. However, Government cannot adhere to the Treaty on the Non-Proliferation of Nuclear Weapons (NPT), as it is an unequal and discriminatory treaty in **its** present form. Government is firmly committed to the policy of utilization of nuclear energy for peaceful purposes and will not accept any interference in the implementation of this policy.
