Increase in the price of manganese ore

803. SHRI BIR CHANDRA DEB BURMAN: SHRI KALYAN ROY:

Will the Minister of STEEL AND MINES be pleased to state:

(a) whether it is a fact that a substantial increase in the price of manganese ore purchased by the steel plants in the public sector has been agreed to between the mine owners and representatives of the SAIL/Steel Plants; (b) if so, what is the increase agreed to for low grade manganese ore per ton for the steel plants and whether it is effective from the 1st April, 1977;

(c) what is the quantity of manganese ore purchased by each steel plant in the public sector and the price paid by each steel plant for the manganese ore from 1974 to 1977, year-wise;

(d) what are the names of the mine owners of these manganese mines and the main suppliers and what is the amount received by them for supply of manganese ore; and

(e) what is the likely impact of the price rise agreed to on the cost of steel production in various public sector steel plants?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): (a) and (b) The question presumably refers to purchase of low grade manganese ore by the Steel Plants at Rourkela, Durgapur and Bokaro in the eastern sector, through Minerals and Metals Trading Corporation. Based on an examination of the increase in wages and other costs of production, an increase in the base price of manganese ore by Rs. 12.20 per tonne has been agreed to by the Steel Plants w.e.f. 1st April, 1977.

(c) The quantity of manganese ore supplied by M.M.T.C. to the Steel Plants at Bokaro, Rourkela and Durgapur during the last three years, and the base price is given below:
